HB 2062 would have added a new A.R.S. § 21-132: "A jury commissioner shall draw and summon a trial jury from the body of the county, except that if one or more judicial districts are established in a county pursuant to court rule, the jury commissioner may draw and summon a trial jury from any portion of the county designated by court rule." The bill failed in the [House Judiciary Committee](#). The companion bill [SB 1001](#) also failed, in the [Senate Judiciary Committee](#).

State of New Mexico. Senate. 2022 Regular Session. [SB 164 Increase Juror Compensation](#).

SB 164 would increase the juror compensation 150%. Currently, jurors receive \$7.50 an hour. This bill would increase that rate to \$17.25. It would also increase the rate that jurors who drive more than 40 miles to get to the courthouse would be paid. As of 2/1/2022, the bill was in the Senate Finance Committee with a "Do Not Pass" from the Judiciary Committee but with a "Do Pass" recommendation from the Senate Judiciary Committee substitution.
