Superior Court Law Library Resource Center Network and Internet Use Guidelines

I. PURPOSE

The following guidelines apply to network and Internet use at the Law Library Resource Center (LLRC). The LLRC does not vouch for the accuracy, completeness, or timeliness of information obtained through the Internet. Verifying the accuracy of information is the responsibility of the originator or producer, and assessing accuracy and timeliness of information is the responsibility of the user. The guidelines of the LLRC regarding the use of this computer includes but is not limited to the following:

II. GUIDELINES

It is unacceptable to use the Law Library Resource Center's (LLRC) computers, network, or Internet access in any of the following ways:

- A. For any purpose that violates applicable federal, state, or local laws and regulations including copyright laws and regulations.
- B. For downloading software, executable files, databases, and similar "live" technology to an LLRC computer or network disk drive.
- C. In a manner that destroys or damages equipment, software, or data belonging to the LLRC.
- D. In a manner that disrupts or interferes with Maricopa County, Superior Court, or LLRC network services.
- E. In a manner that disrupts or interferes with other LLRC computer users. This includes, but is not limited to *harassment of others, and displaying or printing text or graphics that may reasonably be construed as offensive to others*.

Limitations on Use:

- A. The LLRC reserves the right to impose time limitations on the use of LLRC computers.
- B. The LLRC does not offer e-mail accounts. Patrons may use the LLRC's computers to check or send e-mail on an existing remote account *incidental to their legal research and court-related activities.*
- C. LLRC computers may not be used to access social media accounts, except patrons may use the LLRC's computers to access social media accounts *incidental* to their legal research and court-related activities.
- D. LLRC computers may not be used to access instant messaging.

- E. LLRC computers may not be used to access Tik Tok.
- F. Children under the age of 16 may not use the LLRC's computers unless accompanied by an adult.
- G. The Protective Order Area computers shall only be used for purposes related to protective orders. General internet use is not permitted.

Violation of These Guidelines:

- A. Users violating these guidelines will be advised of the LLRC's guidelines for use and will be asked to comply. A failure to comply may be considered as a violation of the LLRC's Use Policy.
- B. The LLRC reserves the right to **terminate network connections** for users who repeat a violation of these guidelines after a previous warning, prohibit those users who violate these guidelines from future access to or use of the library's network services, and **revoke all library privileges** for those users who violate these guidelines.
