

Procedures: How to use the on-line form to request a hearing on a protective order

This online Request form and procedure should only be used:

- to request a hearing on a Protective Order if the Defendant is unable to personally go to one of the four Law Library Resource Centers listed below, and the Defendant has talked to Law Library Resource Center staff at one of the locations below.

This online Request form should NOT be used to:

- request to dismiss an order
- cancel a hearing and order
- request a continuance

***NOTE TO DEFENDANT:**

Certain conditions may cause a defendant to be prohibited from possessing firearms by federal law while an Order of Protection is in effect. The conditions are:

(1) Defendant and Plaintiff are either married (past or present), live together as intimate partners (past or present), or are parents of a child in common, and

(2) the Order of Protection is affirmed or modified at a hearing of which Defendant received actual notice and had an opportunity to participate (even if Defendant fails to appear at the hearing).
